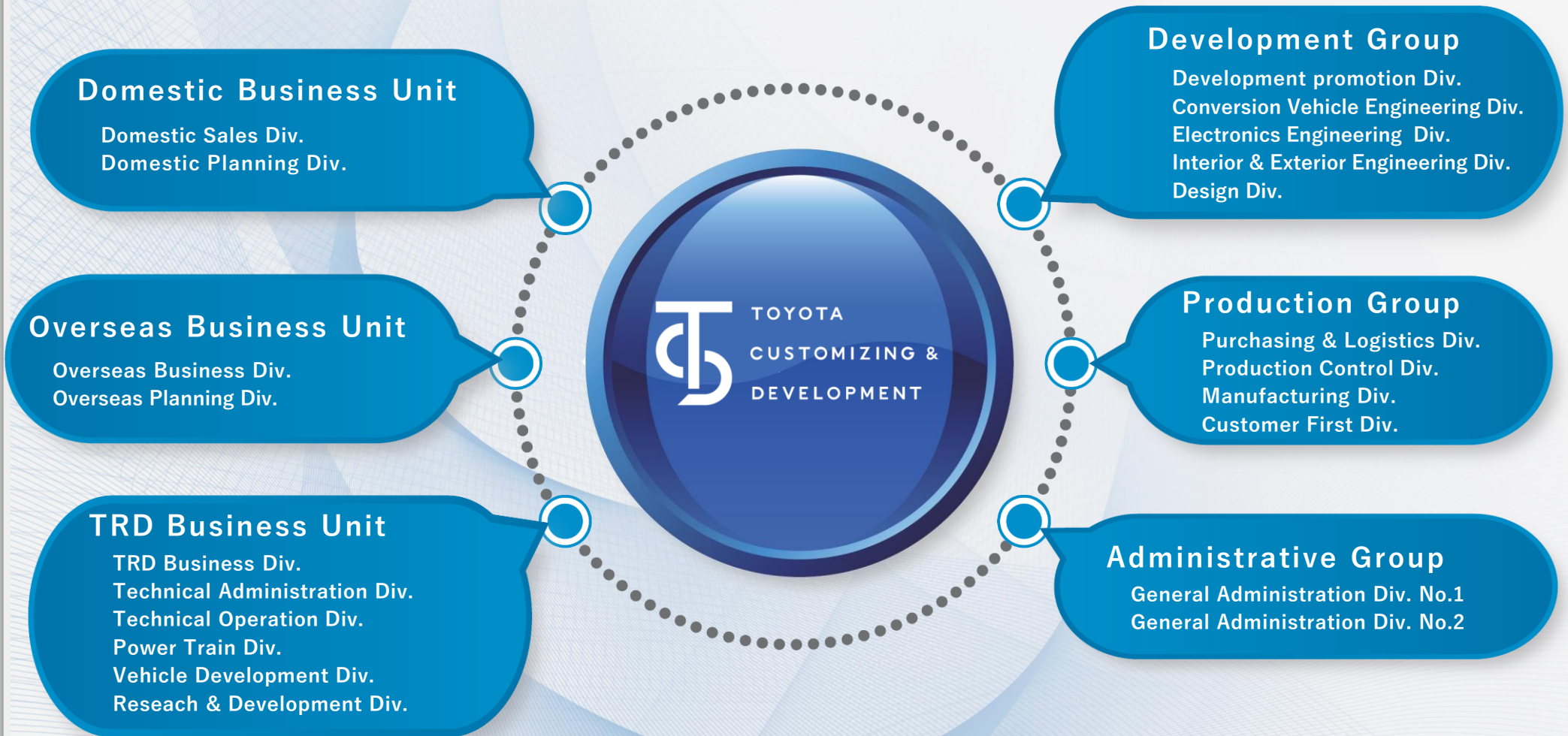




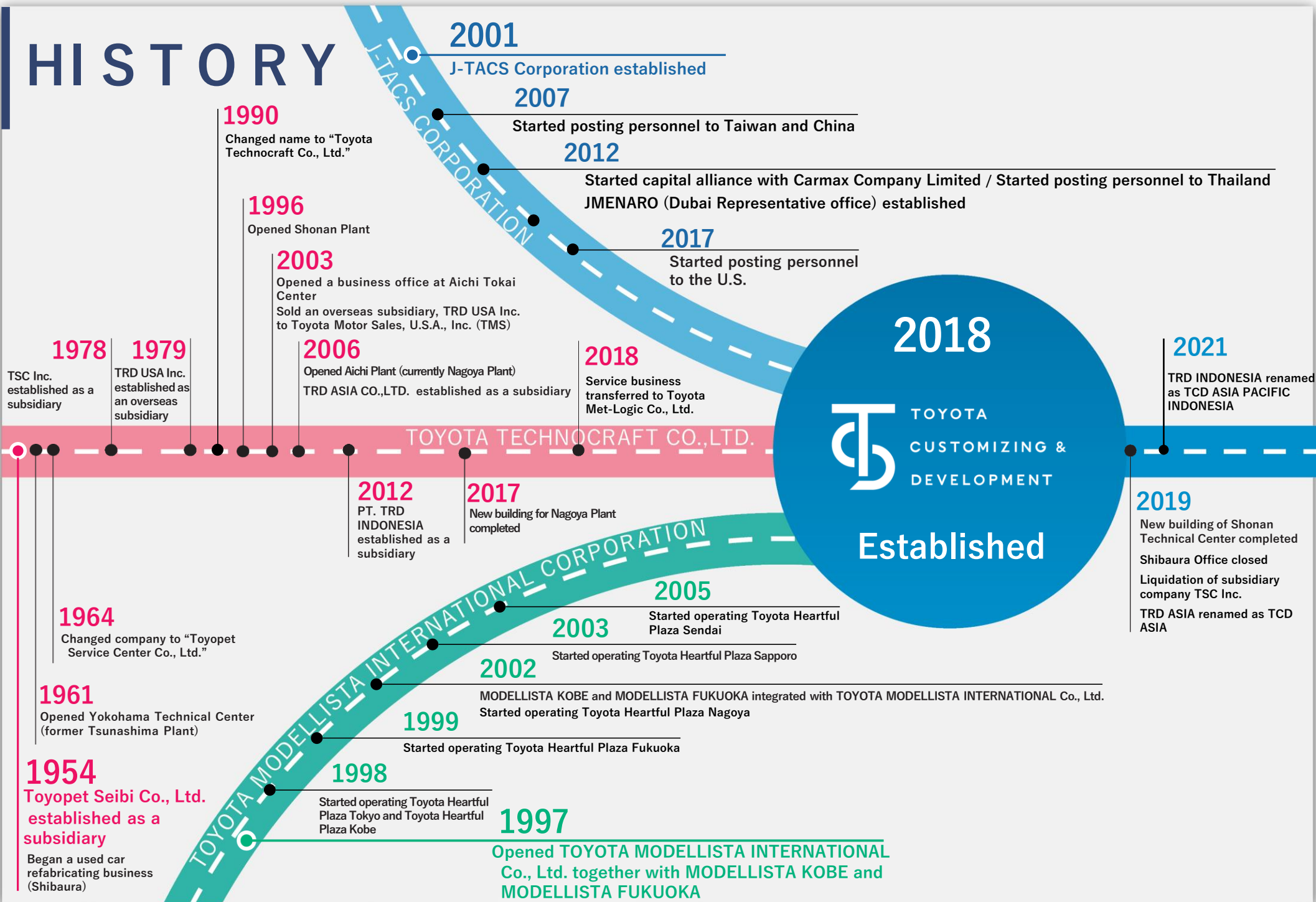

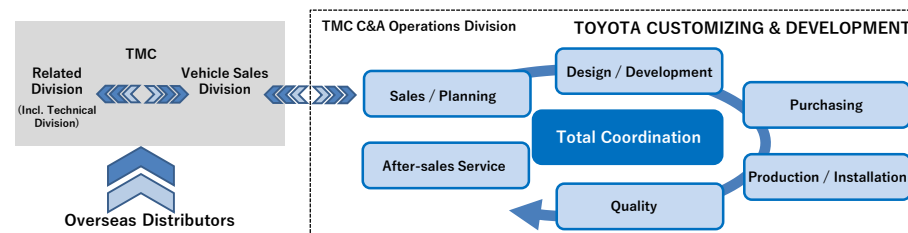
Accessory Business

Various kinds of customized parts simultaneously sold at the time of new vehicle launch

Planning and development of export vehicles that meet various needs of overseas markets



■ Installation and conversion:

Total coordination of the J-PIO business by utilizing Toyota's networks, in terms of marketing, planning, design, development, procurement, production, conversion, quality control and after-sales service

■ Sales and procurement of parts:

Selling and providing accessory parts to overseas distributors efficiently by utilizing Toyota's ordering system (A-TOP) and logistic networks
